Kris is a NC Certified Criminal Justice Instructor with the C.A.L.E.A. accredited N.C. Justice Academy, a division of the Office of the N.C. Attorney General. His main responsibilities, as a subject matter expert, include developing and delivery of course materials for Advanced Traffic Crash Investigation, Traffic Crash Reconstruction, Pedestrian Strike Analysis and Motorcycle Crash Reconstruction. Additionally, he Serves as the Project Director for the NC Governor's Highway Safety Program. Kris is frequently consulted for expert analysis by both highway safety enforcement agencies and Prosecutors throughout the state for technical assistance with resolving highway fatality investigations and prosecutions.

Having started his career in campus law enforcement at Pfeiffer University, where he advanced through the ranks, attaining the position of Chief, Kris has served 25+ years as a sworn N.C. law Enforcement Officer. Kris retains his status as a sworn officer with the Nags Head N.C. Police Department, where assignments included community policing, traffic enforcement, bike patrol, Traffic Crash Reconstructionist, and Field Training Officer.

In April, 2003 Kris received a Life Saving Commendation from the Town of Nags Head, leading to his being honored as the Officer of the Year for 2003. He has received the prestigious Advanced Law Enforcement Certification through the N.C. Criminal Justice Education and Training Standards Commission, in November 2004. Kris also received the Thad B. Wester Award, for his work with the Healthy Carolinians Traffic Injury Reduction Task Force.

Kris is certified by the U.S. Department of Justice, as a Mobile Video Instructor; achieved N. C. certification as a Chemical Analyst and is a member of the NC Traffic Law Forum.
